

Conditions of sale and business

Important notice

Customers who would like to buy through LiveAuctioneers, are kindly requested to pay an extra 5% fee on the awarded price, as the online platform has increased its costs. On the other hand, for those customers who will participate and buy directly from the Auction House through telephone, bidding or on site, the auction fees will be the 18%.

The original text for these Conditions of sale is written in Italian; in case of any difference between the Italian version and the English version, the Italian text will prevail.

The Seller warrants to the Auctioneer and to the Buyer that he is the **true owner** or is properly authorised to sell the property by the true owner.

The highest bidder to be the buyer. If during the auction the Auctioneer considers that a dispute has arisen he has absolute authority to settle it or re-offer the lot.

Lots will be awarded at the **first bid at the starting price**.

Auction fees

The buyer will pay the auction fees for each lot to the extent of 18% on the hammer price up to 50.000 Euro and of 15% for any amount exceeding 50.000 Euro, including VAT and tax burdens.

Lots sold by owners with a VAT identification number have the "+IVA" indication, meaning that the final price (hammer+auction fees) will be added of a 4% tax for used editorial goods and 22% for original arts.

Full payment of the hammer price and buyer's fees can be claimed immediately by Little Nemo Auction House, but in any case, the same must be made within 10 days after the sale.

Little Nemo Auction House will accept **written offers** to be sent within the **opposite form** included in this catalogue. The Auction House will bid on behalf of the customer till the maximum price indicated. **Lots will be acquired at the first bid after the best offer received during the auction.**

Customers could require to be **contacted by phone** to participate directly to the auction. Please contact our offices for further informations.

The buyer shall forthwith upon the purchase give in his name and permanent address together with proof of identity and pay to the Auctioneer an advance payment at the order and the total amount no later than 10 days after the auction.

The buyer shall at his own expense take away any lot or lots purchased no later than 10 days after the payment; otherwise the lots will be kept in repository for 15 days. Every cost will be debited to the buyer. After that period the Auctioneer refuse all responsibility for custody and conservation of the lot.

The Auctioneer guarantee that **every lot is authentic** and in the conditions described in the catalogue.

An exhibition of the lots will be held before the auction. Prospective buyers are strongly advised to examine personally any goods in which they are interested, before the auction take place. **Lots acquired shall be considered as "seen" by the customer.**

All lots are published in our website together with a photo. Our experts are at disposal for any further information and supplementary scans.

The Auctioneer has the right at his absolute discretion to refuse any bid, to advance the bidding in such manner as he may decide, to withdraw or divide any lot, to combine two or more lots and, in case of error or dispute, to put an item up for bidding again.

Due to Italian export regulations, when shipping abroad, every piece of original art and vintage item more than 50 years old has to wait for the approval of the Department of Culture. The process might take up to 15/30 days.

For any dispute the exclusive place of jurisdiction will be the Court of Justice of the city of Turin.
